Re: COVID-19 update

Dear resident/ family member/ representative,

In the last few days, a number of individuals have tested positive for COVID-19 in Melbourne linked to the hotel quarantine program.

Froniditha Care is taking all necessary precautions to ensure the elderly residents and staff of our residential care homes throughout the Melbourne Metropolitan area are safe and that we are taking all steps to prevent the virus from spreading into our care homes.

It is imperative that we all follow the state-wide restrictions that came into effect from 11:59pm, 3 February 2021 with respect to residential aged care that we communicated to you on 4 February.

DHHS Tier 1 sites as of 9 February, 2021

On 9 February 2021, the DHHS added to the list of identified Tier 1 sites and times that individuals who tested positive for COVID-19 visited while infectious.

If you have visited any of the sites on the specific times the DHHS has identified, you cannot visit Froniditha Care.

If you have been to any Tier 1 exposure sites you must immediately isolate, get a coronavirus (COVID-19) test and remain isolated for 14 days.


